WHAT TO DO IF YOU HAVE SYMPTOMS

If you have symptoms of COVID-19:


- Do not report to work
- Inform your appropriate administrator that you are sick
- Contact your medical provider for advice
- If you become symptomatic during the day inform your appropriate administrator and contact medical provider

WHAT TO DO IF YOU TEST POSITIVE

- If you test positive for COVID-19, follow your physician's instructions
- Inform Benefits Service Office for possible leave options

Use of Face Coverings

- The California Department of Public Health requires the use of face coverings inside all public buildings (effective date: 6/18/20, Guidance for Face Coverings PDF)
- Employees working outdoors are also <u>required</u> to wear face coverings whenever 6 feet physical distancing is not possible
 - Example
 - Not required in private office or cubicle



• Required when leaving private space





Face Coverings

- Campus Environmental Health and Safety (EHS) department will provide face coverings to employees.
 - Contact EHS at 278-2020 if needed
 - All employees are welcome to use their own
- Employees who can not wear a face covering and require an accommodation (i.e., medical or religious obligation) should inform the Benefits Services Office and their appropriate administrator.

Use Gloves Properly

- Only use for specific tasks as recommended by EHS
 - Examples:
 - Cleaning/disinfecting
 - Frequent handling of materials touched by others
- Not a substitute for handwashing
- Gloves will become contaminated and can contaminate other surfaces



Practice Glove Safety

- Use non-latex, powder free gloves
- Wash hands after use
- Avoid cross contamination when removing gloves
- Never touch your face or body with gloved hands

Hand Sanitizer

- Hand sanitizer will be provided in individual spray bottles and throughout campus
 - Sanitizer provided will contain at least 60% ethyl alcohol as required for disinfection
 - Read and follow the instructions and warnings on the container label
 - Bottles are refillable, please contact EHS for replacement

NuRinse Hand Sanitizer

Use: Spray several times front and back of hands, rub surface of hands together to distribute. Allow to air dry.

Warning

Active Ingredients: 80% Ethanol

Flammable liquid and vapor. Keep away from heat and flames. Avoid contact with eyes. Causes eye irritation. Wear eye protection or face protection if risk of splashing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention. In case of fire: Use CO2, powder spray, or water spray for extinction. Store in a well-ventilated place. Keep cool. Dispose of contents/container to EHS x82020 or rms@csus.edu.

Use Cleaning/Disinfecting Products Safely

- Do not purchase concentrated cleaner
- EHS will provide diluted cleaning/disinfecting products and safety equipment as needed
- Call 916-278-2020 for assistance
- Read and follow all product labels
- **NEVER** mix products



Surface Disinfecting Solutions



- Surface sprays provided are EPA listed for effectiveness against COVID-19
- A safety data sheet (SDS) will be provided with each container and safety information printed on the label.
- All disinfecting solutions provided are irritating to the skin.
 - Wear nitrile gloves
 - Spray away from yourself onto paper towel and wipe on surface
 - Wash hands thoroughly after removing gloves.



Steps for Safe & Effective Disinfectant Use

- Read the directions
 - Wear nitrile gloves provided
 - Spray away from yourself onto paper towel and wipe on surface
 - Wash hands thoroughly after removing gloves



Ensure surface remains wet for contact time identified on the label





Campus Authority Structure For COVID-19 To Protect The Campus Community

- Administration
 - Approve the start of all campus activities
 - Approve Campus-wide COVID-19 Safety Plan
- Student Health and Counseling Services
 - Campus Health Liaison to Sacramento County Public Health.
 - Resource for employee COVID related questions
 - Contact SHCS at 916-278-6461



Campus Authority Structure For COVID-19 To Protect The Campus Community

- Managers/Appropriate Administrators
 - Develop location specific safety protocols with assistance from EHS
 - Instruct employees on the contents of the protocol and monitor compliance



Campus Authority Structure For COVID-19 To Protect The Campus Community

- EHS
 - Assist departments in workplace specific
 COVID-19 safety protocols
 - Provide COVID-related protective equipment, cleaning and disinfecting supplies
- Staff and Faculty

 Follow all campus polices and work plans designed to reduce infection
